




3rd. DIES LA Alumni Networking Meeting

CALL FOR ABSTRACTS

Scope of the Meeting

The enrollment rates at higher education institutions in Latin America have been

steadily increasing in recent years. Nevertheless, LA countries are still facing a lot of challenges – from political and economic instability to mass migration – which directly impact regions' higher education institutions.

The meeting aims at providing best practices in different areas of the LA higher education system. It will provide a snapshot that illustrates how challenges in higher education may be faced from different perspectives. The aim of the meeting is to share the knowledge among all participants in different areas of interest and provide a framework for open discussions on the different topics.

The Call

The meeting organizers invite abstracts and roundtable proposals for consideration to form part of the 3rd DIES IDC LA Alumni Networking meeting in Latin America to be held in Santo Domingo on the 27th and 28th March 2020. The call is aimed at all DIES IDC LA Alumni.

Abstracts

We invite abstracts which address one of the conference topics (overleaf). The abstracts may include: research results, case studies and/or presentations based on experiences gained through practice and decision-making.

Abstracts must be a maximum of 350 words, excluding references. They should be provided in English, in a Microsoft Word format, in Times New Roman font, pt. 12 with double spacing.

Successful applicants will be invited to submit an extended abstract (max. 1000 words) to be presented at one of the sessions of the meeting in the form of a power point presentation.

Roundtable proposals

The roundtables are intended to enable discussions surrounding innovative solutions to challenges relevant to the topic session.

Proposals should detail the topic of the roundtable. They must be a maximum of 350 words, excluding references, with 3-5 keywords. They should be provided in English, in a Microsoft Word format, in Times New Roman font, pt. 12 with double spacing.

- ✓ Internationalization
- ✓ Research Management
- ✓ Human Resources Management

Review process

- > Only submissions that follow the length and format guidelines will be accepted
- > Two reviewers to ensure quality will review submissions. They will be selected randomly from members of the Program and additional reviewers if necessary
- > Each submission must be related to at least one of the main conferences topics
- ➤ Each contribution must have a title
- > Abstracts will be in English only. No other language will be accepted

➤ Author name(s), affiliations and contact details should be provided on a separate title page, in the same document
